**Member Responsibilities Include:**

1. Making sure the track is in safe condition and that all the people using the track are members in good standing and have the proper safety equipment.
2. Attending as many club functions as possible, either racing or officiating.
3. Keeping the Gate closed and locked at all times.
4. Key and membership card must be in your possession when at the track.
5. Informing the BMKC Board of all violations of the rules.

# PLEASE READ BEFORE SIGNING MEMBERSHIP APPLICATION

## RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as including but not limited to the racing surface, pit areas, infield, approach area, shut down area, and all walkways, and other areas appurtenant to any area where any activity related to kart driving shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the club, THE UNDERSIGNED, for him/her self, his personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he/she has, or will immediately upon entering any such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he enters and which he/she enters and comes in contact, and he/she does further warrant that his/her entry upon such restricted area or areas and his/her participation, if any, in Blue Max Kart Club constitutes an acknowledgment that he/she has inspected such restricted area and finds and accepts the same as being safe and reasonably suited for the purpose of his/her use. He/she further agrees and warrants that if, at anytime, he/she is in or about restricted areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the restricted areas:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE BLUE MAX KART CLUB, participants, racing association, sanctioning organization, track owner, officials, kart owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releases," from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefor on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in, observing, working for, or for any purpose participating in the club

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the club and whether caused by the negligence of the releases or otherwise.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence or releases or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the club.

THE UNDERSIGNED expressly acknowledges and agrees that the activities of Blue Max Kart Club are very dangerous and involve the risk of serious injury and/or death and/or property damage. THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the club is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
